- The New Zealand Guardian Trust Company Limited is the Supervisor of the Scheme.

#### **Changes relating to the Scheme**

The following material changes occurred to the Scheme during the Year:

The Scheme transitioned to the Financial Markets Conduct Act 2013 (FMCA) regime on 27 May 2016. Changes to the Scheme's trust deed (Trust Deed) were required to ensure the Scheme's compliance with the FMCA and the Financial Markets Conduct Regulations 2014.

A new Statement of Investment Policy and Objectives (SIPO) was published on 27 May 2016 as part of the Scheme's transition to the FMCA.

There were no material changes to the terms of the offer of the Scheme, or to the nature or scale of related party transactions, and all related party transactions were conducted on arm's-length and enacted on standard commercial terms.
