# Fund Update for the quarter ended:

### 30 September 2025

This fund update was first made publicly available on 29 October 2025.

#### What is the purpose of this update?

This document tells you how the Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited¹ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Conservative Fund aims to provide relatively stable returns over the short to medium term. The fund invests primarily in income assets but also has a 25% target allocation to growth assets. Volatility is expected to be higher than the Defensive Conservative Fund but lower than the Moderate Fund in the Westpac KiwiSaver Scheme.

#### What are the risks of investing?

Risk indicator for the Conservative Fund.<sup>2</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


#### How has the fund performed?

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason received a return after fund charges were deducted of \$592 (that is 5.92% of his initial \$10,000). Jason did not pay anything in other charges. This gives Jason a total return after tax of \$592 for the year.

The top 10 investments make up 9.78% of the net asset value of the fund.<sup>7</sup>

#### **Currency Hedging**

Some of the asset classes in the fund have exposure to foreign currencies. As at 30 September 2025, the actual currency hedging is as follows:

- International fixed interest 99% hedged (benchmark 100%)
- Australasian equities 66% hedged (benchmark 70%)
- International equities 56% hedged (benchmark 60%)
- Listed property (Australasian) 100% hedged (benchmark 100%)
- Listed property (International) 138% hedged (benchmark 139%)
