This fund update was first made publicly available on 28 July 2022.

What is the purpose of this update?

This document tells you how the Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited¹ prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Growth Fund aims to provide higher returns over the long term. The fund invests primarily in growth assets but also has an allocation to income assets. Volatility is expected to be the highest of the funds in the Westpac KiwiSaver Scheme.

What are the risks of investing?

Risk indicator for the Growth Fund.²



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

The market index return used from 29 September 2021 and the composite market and peer group index used prior to this date reflect a composite of benchmark index returns, weighted for the fund's target asset allocation. The benchmark indices used for each asset class are defined in the Statement of Investment Policy and Objectives (SIPO).

Effective from 21 June 2022, there has been a change to the underlying market index for Australasian equities, an asset class included in the market index. This change occurred so that the market index was more reflective of the underlying assets of the asset class.

Annual return graph³



This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 30 June 2022.

Important: This does not tell you how the fund will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

*From 28 September 2021, the Manager estimates that the total fund charges for the next scheme year will reduce to 0.55% of the fund's net asset value. For further information on the total fund charges refer to the PDS.

Small differences in fees and charges can have a big impact on your investment over the long term.

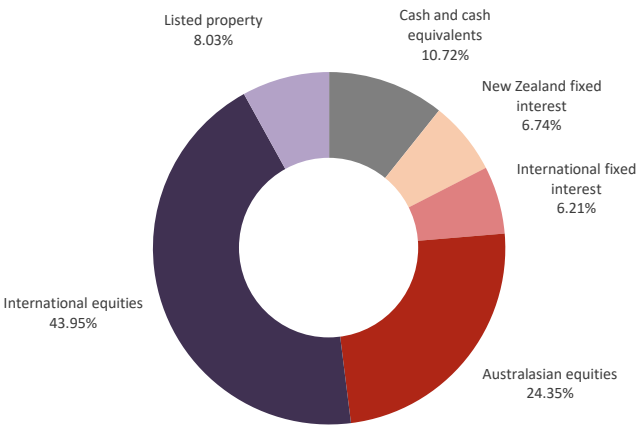
Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason incurred a loss after fund charges were deducted of -\$1,195 (that is -11.95% of his initial \$10,000). Jason also paid \$6 in other charges. This gives Jason a total loss after tax of -\$1,201 for the year.

The top 10 investments make up 14.93% of the net asset value of the fund.⁸

Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 30 June 2022, the actual currency hedging is as follows:

- International fixed interest – 97% hedged (benchmark 100%)
- Australasian equities – 93% hedged (benchmark 70%)
- International equities – 52% hedged (benchmark 51%)
- Listed property (Australasian) – 103% hedged (benchmark 100%)
- Listed property (International) – 139% hedged (benchmark 139%)

Notes

1. BT Funds Management (NZ) Limited is the scheme provider and Westpac New Zealand Limited is the distributor of the Westpac KiwiSaver Scheme.
2. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in this fund update (or the PDS) may provide a less reliable indication of a fund's potential future volatility.

The return on the composite index, which was used up until 28 September 2021, has been used in the following ways, because there was no appropriate market index for the exposure to Other assets: in the How has the fund performed? table, and in the Annual Return Graph Index bars, applicable from 1 April 2016. A composite index may be a less reliable indicator of performance than an appropriate market index. The return for the peer group index used in the composite index and reflected in the table and the bar graph is net of fund charges and trading expenses (if any) but before tax.
