### Fund Update for the year ended:

This fund update was first made publicly available on 30 June 2022.

#### What is the purpose of this update?

This document tells you how the Balanced Portfolio has performed and what fees were charged. The document will help you to compare the fund with other funds. BT Funds Management (NZ) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Balanced Portfolio aims to provide medium returns over the medium to long term. The Balanced Portfolio has a higher benchmark allocation to growth assets than to income assets. Volatility is expected to be higher than the Accumulation Portfolio but lower than the Dynamic Portfolio.

#### How has the fund performed?

#### What are the risks of investing?

Risk indicator for the Balanced Portfolio.<sup>1</sup>



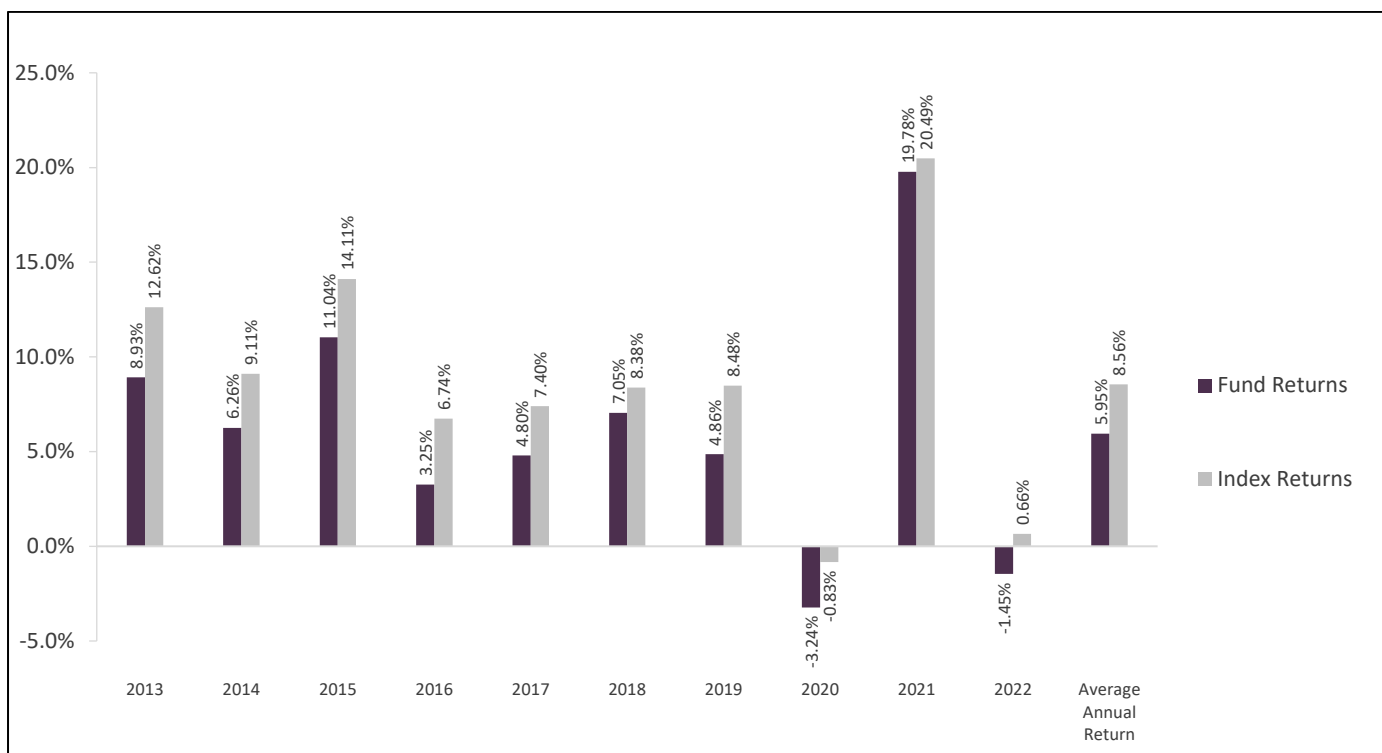
The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

This risk indicator is not a guarantee of a fund's future performance. The risk indicator is based on the returns data for the five years to 31 March 2022. While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

## Annual return graph<sup>2</sup>



This shows the return after fund charges and tax for each of the last 10 complete years ending 31 March. The last bar shows the average annual return for the last 10 years, up to 31 March 2022.

**Important:** This does not tell you how the fund will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

Small differences in fees and charges can have a big impact on your investment over the long term.

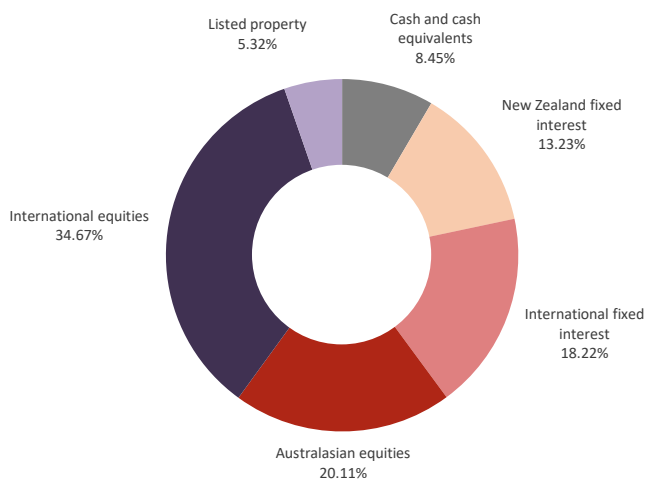
## Example of how this applies to an investor

Jason had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jason incurred a loss after fund charges were deducted of -\$145 (that is -1.45% of his initial \$10,000). Jason also paid \$5 in other charges. This gives Jason a total loss after tax of -\$150 for the year.

The top 10 investments make up 12.81% of the net asset value of the fund.<sup>7</sup>

## Currency Hedging

Some of the asset classes in the fund have exposure to foreign currencies. As at 31 March 2022, the actual currency hedging is as follows:

- International fixed interest – 98% hedged (benchmark 100%)
- Australasian equities – 99% hedged (benchmark 100%)
- International equities – 51% hedged (benchmark 51%)
- Listed property (Australasian) – 100% hedged (benchmark 100%)
- Listed property (International) – 137% hedged (benchmark 139%)

## Notes

1. The risk indicator for the fund is calculated based on the volatility of returns over the past five years, which may not be a full investment cycle. In some cases the risk indicator might differ if calculated using a longer timeframe. We believe an average investment cycle is generally considered to be a period of between 7 to 10 years. If the period of returns data that a risk indicator is based on has had unusually low or high volatility the risk indicator presented in a fund update may provide a less reliable indication of a fund's potential future volatility.

The return on the composite index, which was used up until 28 September 2021, has been used in the following ways, because there was no appropriate market index for the exposure to Other assets: in the How has the fund performed? table, and in the Annual Return Graph Index bars, applicable from 1 April 2016. A composite index may be a less reliable indicator of performance than an appropriate market index. The return for the peer group index used in the composite index and reflected in the table and the bar graph is net of fund charges and trading expenses (if any) but before tax. 3. The amounts specified include GST, where applicable.
4. Other charges are the Administration fee, which is the total of the weekly fixed dollar charges for membership in the Westpac Retirement Plan. You will pay this fee only once each week even if you are invested in multiple funds within the Westpac Retirement Plan. This fee may be waived if you have an Account balance of more than \$12,000. The Administration fee was removed from all members from 1 June 2021.
